The Second IAACA Seminar will be held from 14th to 23rd May, 2008 in Chongqing, China. On behalf of the International Association of Anti-Corruption Authorities and the Supreme People's Procuratorate of the People's Republic of China, it gives me great pleasure to invite you to participate in and lecture at the Seminar. The accommodation and transportation fees during your stay in China will be borne by the Supreme People's Procuratorate.

In order to further fulfil the resolution of the Second Annual Conference of the IAACA and related subjects of Conference of the States Parties to the UNCAC, the theme of our Seminar in Chongqing will be "Effective Preventive Measures in the Fight against Corruption".
